ALL SPACE ASSIGNMENTS ARE FINAL. No further changes will be made on the day of show.

PAYMENT: The completed and signed contract, event fees payable in full made payable to McKean Community Day.

RETURN CHECK: Tenant will be charged a fee for any check returned by tenant's bank.

SET-UP: Set-up is Saturday, August 3, 2019 7:00am until 9:30am.

EVENT HOURS: Tenant is required to be ready for business one half hour prior to opening and **MUST** be fully operational until 3pm or if you choice to stay operational until end of Fireworks you cannot move your vehicle until after Fireworks.

ELECTRICITY: Electricity is not included. At this time of year, it will be daylight longer. If necessary, you may bring battery powered lights.

OUTDOOR BOOTH SPACE: Space includes a 12ft x12ft area. **NO electricity.** Provide your own tables, chairs and displays. Area shall be left in the same condition in which it was found. At the close of the show, remove **ALL** your debris. Operations are to stay within booth space.

PARKING: Parking will be provided for 1 (one) vehicle with parking permit at Rec Park.
